## Sessions - round 1

### 1. Development of joint education in practice

Dutch Hei's are involved in various initiatives with international partners to jointly develop programmes at bachelor's, master's, and at PhD level. In this session we share experiences within Alliances and Erasmus Mundus and discuss the challenges and solutions.

Practical examples: Femke ten Bloemendal and Annet van der Riet from CHARM EU (Universiteit Utrecht) and Nicole de Leeuw from Breda University of Applied Sciences

### 2. Interoperability within the European University Alliances

European University Alliances operate in a complex digital landscape, where interoperability between systems and platforms is essential for effective collaboration. This session starts with a mapping conducted within the Higher Education Interoperability Working Group (of the European Digital Education Hub). This has resulted in a framework that maps out different approaches to interoperability. Practical examples will be highlighted. They will share how interoperability is achieved within their Alliances

Practical examples: David Pho from EPICUR (University van Amsterdam) and Ben Parker from EuroTeQ (Technische Universiteit Eindhoven)

### 3. Leadership & Governance in practice

Leadership in the Alliance: internal in partner university and at the Alliance level. Failure and success stories. Governance of the Alliance: challenges and benefits. How to make the governance effective for the alliance but also at the partner level?

Practical examples: Rima Dijkstra from STARS EU (Hanzehogeschool Groningen) and Liv Hassinger from ECIU (Universiteit Twente)

### 4. Internal stakeholder engagement

How do you create support for your alliance within your institution? (or not) In this session 2 alliances will share their experiences, challenges and good practices.

Practical examples: Guido van Leerzem from ENGAGE.EU (Tilburg University) and Peter de Boer from RUN-EU (NHL Stenden Hogeschool)

### 5. Research within an alliance; how to start and what about implementation?

Organizing research within an alliance can be complex. In this session an example from a newly starting alliance will be discussed: how to begin, what to consider, how to develop projects and research proposals together. Additionally, another alliance that is working with pilot training programs for PhDs and postdocs will be highlighted. They have also applied for an MSCA cofund with all their partners.

## Sessions - round 2

### 1. Development of joint education in practice

### 2. Impact models in practice

In this session, impact models in practice within education will be presented. Examples on societal impact, International Community Service Learning, Coil collaboration within South-South and other examples will be discussed.

### 3. Student engagement

This session addresses student involvement. The student's voice should be central as it contributes to the further development and refinement of the alliance's objectives. But what does this mean in practice? What is the added value of involving students in alliances? And how can the objectives of the alliances be aligned with the needs of the students? During this session we will address these questions with the aim of exploring and highlighting the benefits of student engagement.

Practical examples: Andra van der Burg and Gemma van der Sluijs from NeurotechEU (Radboud Universiteit) and Student perspectief

### 4. Innovative mobility formats and what about the 50% mobility ambition?

This sessions combines 2 topics. Alliances are invited to create new mobility formats, learning experiences. At the same time they have to deal with the 50% mobility ambition. 2 alliances will share good practices and the challenges they meet to realise their ambitions.

Practical examples: Nati Mansilla Ovejero and Delfien Cloet from ENLIGHT (Rijksuniversiteit Groningen and Universiteit Gent, Belgium) and Isabel Crespo from UNIC (Erasmus Universiteit Rotterdam)

### 5. European alliances, consortia and financing

Formal alliances have been funded so far by the EC and OCW. What does the future look like? What are scenarios to ensure the sustainability of the alliance? What about other alliances who did not get funding? In this session these questions will be discussed.

Practical examples: Marije Braun from Hogeschool Utrecht and Sabine Ambft from Haagse Hogeschool

### 6. The shared strategic interest of alliances for the Dutch Higher Education sector

We are compiling a position paper on the strong strategic interests of the Netherlands's universities (including Universities of applied sciences) in building a future-proof higher education system. In this round table session, we will discuss and refine the key points from three angles: education, including the European Degree and lifelong learning; research collaboration; and regional development.
